

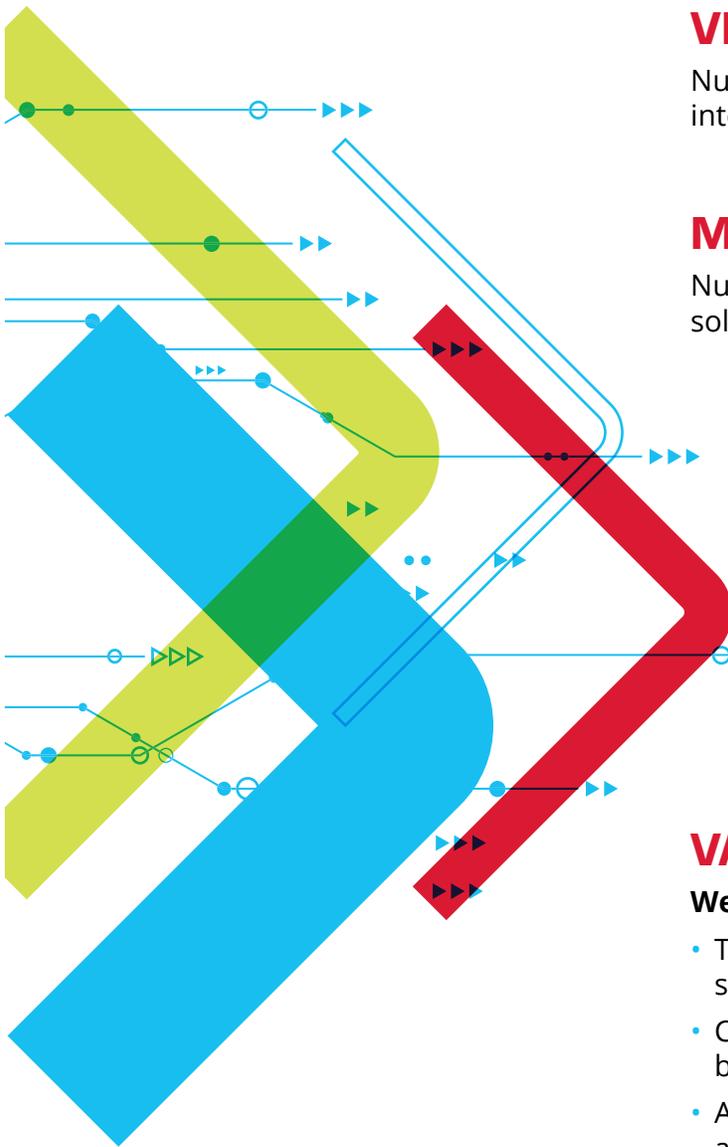

TO OUR **SHAREHOLDERS**

THE SPEED OF THE FUTURE HAS ARRIVED. In 2022, Nuvera achieved the first of several milestones on our strategic roadmap as we invest to grow with a 100% fiber network. One year ago, we announced the historic investment to build Nuvera Gig Cities. The investment delivers on Nuvera's purpose to create connections for communities as a leading regional service provider. Demonstrating our strength, Nuvera built the foundation for our new fiber network this year by mapping, engineering and beginning construction in nearly every community we serve. Nuvera began rolling out service in the fall, reaching 25% of Nuvera customers with fiber-to-the-home connections. Our success provides momentum for 2023, with plans to double our results reaching 50% of Nuvera customers with fiber-to-the home.

The work to transform Nuvera's network to fiber ushers in a new era, one that's truly transformational for all of our stakeholders. Data consumption and new applications are predicted to drive demand for Gig speeds faster than ever before.

Nuvera's investment in fiber's superior technology provides a future-proof foundation for service delivery with the capacity to upgrade speeds for customers and hold a competitive market position well into the future.

In 2023, Nuvera will:

- Accelerate the expansion of Nuvera's fiber-to-the-home connections enabling fiber connections in more than 15 communities and over 35,000 total fiber passings.
- Reach a key milestone with 50% of the network fully transitioned to fiber on our way to serve customers with a 100% fiber network in 2024.
- Drive new customer growth by extending Nuvera's network into new communities.
- Focus on exceptional service to customers and with simplified customer experience.

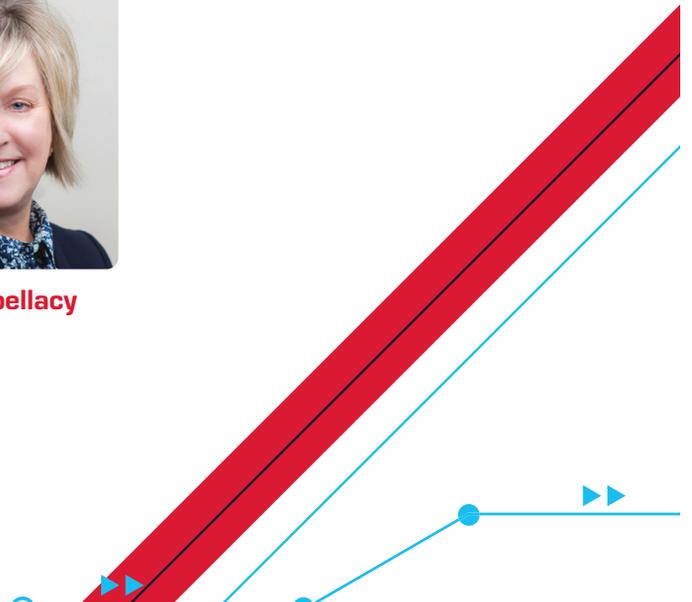
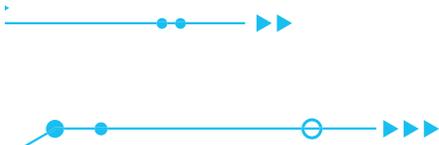

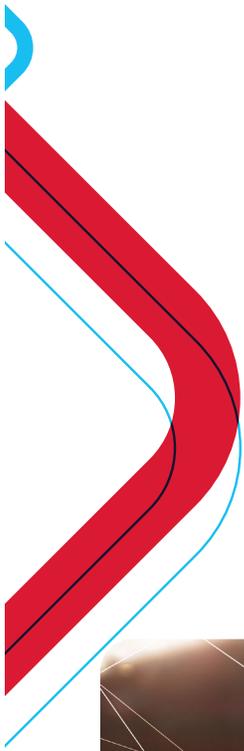




BUILDING TO GROW

THE YEAR BROUGHT SIGNIFICANT PROGRESS at Nuvera as we embarked on the largest multi-year infrastructure project in company history. We met with community leaders to share plans, maps and engage community support early in the year, followed by an accelerated construction season later in the year.

Nuvera's fiber network deployment began with early efforts to secure materials and contract partners. Nuvera teams deployed crews across several communities and successfully managed more than 80 projects simultaneously. We applied continuous improvements to processes, expanded communication, and built operational strength.





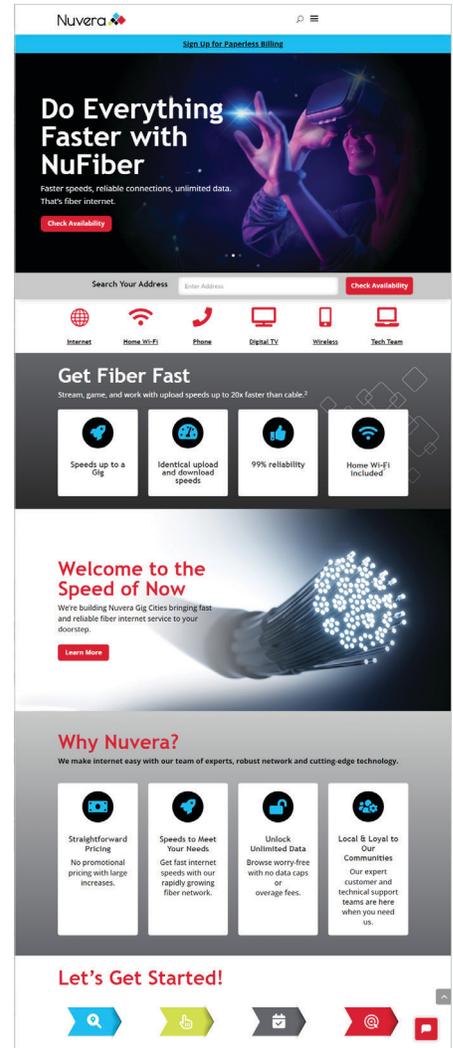
A STRONG FOUNDATION



NUVERA'S 118 YEARS OF SERVING CUSTOMERS reflect our strong foundation of innovation and successful evolution. In 2022, Nuvera put new focus on evolving the customer experience with enhanced digital tools and a simplified customer experience.



NUVERA'S INVESTMENT IN DIGITAL TOOLS in 2022 is the result of acting on expert research and responding to all the ways residential sales are evolving. Digital tools enhance customer experience and build strength for sales enablement as we ramp up conversions in 2023.



NUVERA'S NEW WEBSITE serves as an enhanced digital front door. It enables new digital integration with easy site navigation with sales, product and customer service. An interactive service map allows customers to enter an address and search service availability. Customers can make purchases anytime through a new e-commerce shopping cart from a computer or mobile phone.



ACCELERATING PROGRESS



As Nuvera accelerated progress on Nuvera Gig Cities this year, we built awareness around our leadership role in the industry and the State of Minnesota's efforts to reach broadband goals. Nuvera hosted a roundtable with the Minnesota Department of Employment and Economic Development in Hutchinson. The event gathered Commissioner Steve Grove, Glenn Zerbe, business owners, education leaders and others to discuss the critical need for fiber broadband.

DEED Commissioner Steve Grove moderated the roundtable and spoke to the importance of reliable broadband connections for everyday life.

"Saying 240,000 households (in Minnesota) don't have access to broadband, that is kind of like saying there's 240,000 households in this state that don't have access to the modern economy, or modern plumbing, or pick your analogy," said Commissioner Grove. "But life doesn't work without broadband. And companies like Nuvera are making sure that (access) happens."

Nuvera's CEO Glenn Zerbe pointed out how the need for fast fiber connections, because the way people connect at home, has changed.

"It's not just Netflix creating and sending out streaming content," Zerbe said. "Content is being created and shared from the home and it's that new and growing dynamic that's changing everything."

The pandemic created a surge in demand for connectivity between home, school and students. Educators at the roundtable shared that demand continues to only grow.

"Need for bandwidth hasn't changed, because instruction is permanently changed," said Hutchinson Superintendent, Daron VanderHeiden. "If a student is marked absent during the day, their teacher may send them a video lesson to view and complete online, not wait until they are back in the classroom."

In an effort to reach Minnesota's broadband goals, the Minnesota Department of Employment and Economic Development rolled out the application process for the largest ever number of grants to support rural access. We're pleased to share Nuvera successfully applied and won several grants totaling \$8.6 million to support rural access projects in our service territory. Those investments will roll out in 2023 and 2024.

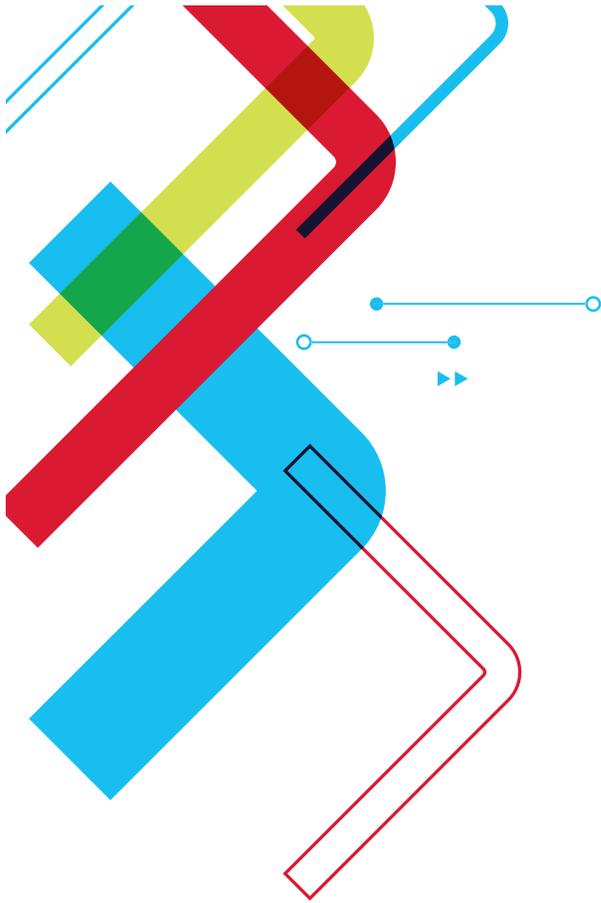

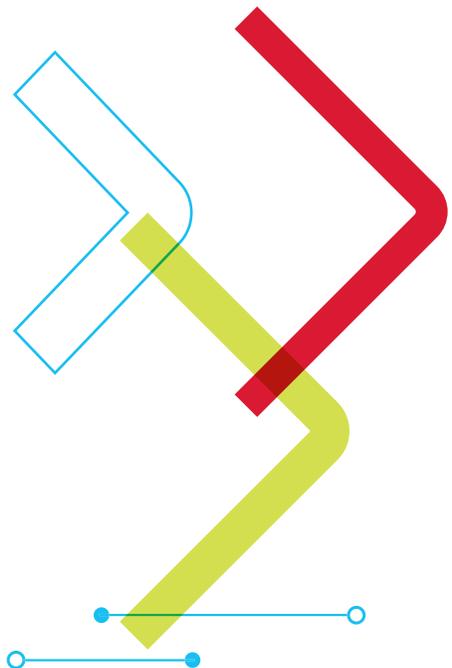

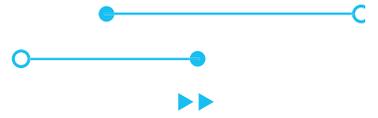
